1. PLEDGE OF ALLEGIANCE:

Mayor Knickerbocker called the meeting to order at 7:00 P.M. The Buchanan Engine Co. #1 led the Pledge of Allegiance and informed every one of the fire regulations.

2. APPROVE MINUTES:

January 7, 2025 Board Meeting January 28, 2025 Workshop Meeting.

A motion to approve these minutes as presented was made by Mayor Knickerbocker, seconded by Trustee Baez with all in favor.

3. COMMENTS FROM THE FLOOR (agenda items only):

Gary Bell made public comment about the roadwork to be done on Church Street. Alice Rivera, Director from Through the Looking Glass spoke about the drop-off and dismissal procedure. Lisa Wenz commented that it is important that the Board listen to the Director because she knows what she needs in her school. There was further discussion by the Board.

Nicolas Zachary wished Bob Wheeler a speedy recovery. Mr. Zachary supports Mr. Hesselgrave to be the General Foreman. Mr. Zachary made public comment about the re-zoning of Indian Point.

Fire Chief Bob Outhouse spoke on agenda item h. the determination of request from Buchanan Engine Co#1 regarding letter of authority. He sent the Board a list of what the Buchanan Engine Co. EMT members have done since 1989 responding to calls in

the Village. He would like the fire department to receive an agency number. There was discussion involving the liability to the Village.

Tania Drezik stated that Randy Hesselgrave would be a good choice to replace Scott Horton as General Foreman.

4. NEW BUSINESS:

a. Continuation of Public Hearing Regarding Parking Restrictions on Intersections.

A Motion to open the Public Hearing was made by Mayor Knickerbocker, seconded by Trustee Baez with all in favor.

Mayor Knickerbocker gave a brief overview. This has been opened for several months. There was discussion on which intersections and what signage would be needed. Nick Zachary questioned if a painted curb would suffice instead of signage. Eileen Absenger asked what the fire department thought about signage throughout the entire Village instead of just pinpointing certain areas. She is in favor of doing the entire Village. Chief Outhouse stated that they have spoken to the Board and the Police Chief about their concerns. It was decided that this will be held over to the next meeting.

A Motion to Continue the Public Hearing at the next meeting was made by Mayor Knickerbocker, seconded by Trustee Capicotti with all in favor.

b. <u>Discussion on State Grant.</u>

Mayor Knickerbocker advised that this is \$100,000.00 grant from Senator Harckham. Randy Hesselgrave and Scott Horton spoke about getting a F600 with a hook lift. It will be \$40,000.0 over the grant. They would like to go with the rack body with the steel floor, the lift gift and a regular steel dump body. This truck will be very efficient for the highway department. The Board agreed to move forward with this.

Village Engineer Pommer stated that as part of the WIAA grant, the Village is obligated to sign an agreement. As part of that agreement the Village has to pass a resolution committing some funds to the project. The EFC has requested some changes to the resolution and would like to have a meeting to discuss this further. This resolution has been tabled.

d. Consider a Motion to Appoint a General Foreman at the Time of Scott Horton's Retirement at a Rate of \$122,506.00.

A Motion to Appoint Randy Hesselgrave as General Foreman at the time of Scott Horton's Retirement at a Rate of \$122,506.00, seconded by Trustee Baez, with Trustee Stewart and Trustee Wheeler in favor and Trustee Capicotti not voting as he did not have a chance to do the interviews.

e. Consider a Motion to Approve the Volunteer Firefighters that have met the Required 50 Points for the Service Award Program as Provided by the Village of Buchanan Fire Department.
